and they were attempting to fix them.

I spoke with Magnola who stated he was on his way to Bunnell when both his tires popped. Magnola said he was trying to fix the tires. While speaking with Magnola, I noticed that he had an empty knife sleeve around his neck. I also observed a knife in his waist band. At this time, I retrieved the knife for officer safety from Magnola waistband. Magnolia asked Humphrey were they lived in Bunnell and she replied they live at 408 N Pine Street in Bunnell Fl.

While speaking with Magnola and Humphrey they both seemed under the influence of narcotics. They both had pin point pupils, slurred speech, very slow movement, and could not follow directions or commands.

Humphrey wanted to get her phone out of the vehicle. I followed Humphrey back to the vehicle to retrieve her phone out of the vehicle. While Humphrey was grabbing her phone from the vehicle, I observed; in plain sight a green plant material inside a plastic bag, in the pocket of the open passenger side door. I asked Humphrey what was that. Humphreys advised it was a nugget (slang for marijuana) she advised she was [REDACTED] Humphrey stated she did not have a medical marijuana card. Humphrey asked if I could write her a ticket for the weed. I advised Humphrey to go back to the rear of the vehicle and attempt to call for a ride. Humphrey still wanted to go inside the vehicle and retrieve her purse. I followed Humphrey back to the vehicle while she retrieved her purse. While she was going inside the vehicle to grab her purse, I observed Humphrey going through her purse and the center counsel attempting to hide something; which appeared to be a plastic bag with a white powdery substance inside from her purse. At this time, I told her to step out of the vehicle and walk towards the other officer without her purse. I searched the purse and located a plastic bag with white powdery substance; suspected to be cocaine.

I searched the vehicle and located a plastic bag with gray powdery substance inside (suspected to be heroin or fentanyl), scale, glass pipe, a lighter in the center counsel.

At this time, I requested a female officer and advised dispatch that both Magnola and Humphrey were under arrest for narcotics.

Deputy Cooper responded to the scene and searched Humphrey. Deputy Cooper located a plastic straw inside Humphrey's bra.

I field tested the white powdery substance; which field tested positive for cocaine.


I read Magnola his Miranda Warning Magnola advised he understood his rights and was willing to speak with me. Magnola stated [REDACTED]

Deputy Williams read Humphrey her Miranda Warning.

Both Magnola and Humphrey were transported to Flagler County Inmate Facility (FCIF) by myself and Deputy Cooper.

While at FCIFI, I, along with Detective Capela field tested the gray powdery substance; which field tested positive for Fentanyl. It weighed approximately 21.44 grams. The white powdery substance tested positive for cocaine and weighed approximately 7.89 grams.

Both the Fentanyl and cocaine where packaged and sent to the FDLE Lab for analysis and weight. All other drug paraphernalia were seized and placed into evidence.
