The Search Warrant was executed on Tuesday, July 27, 2021. All participating parties involved met and briefed at a predetermined location at approximately 5:30 A.M. The nature of the Search Warrant was reviewed. At approximately 6:00 A.M., all units arrived on scene at 25 Shady Lane N. Members of the Flagler County Sheriff's Office (FCSO) SWAT team knocked on the front door of the residence, and announced the presence and purpose of the Sheriff's Office. After SWAT made several announcements, Zachary Pierce and Danielle Mullener exited the residence through the side door and were secured for safety. The SWAT team entered the residence and cleared the residence. Zachary and Danielle were provided a safe place to sit outside near the front of the residence during the execution of the Search Warrant. At approximately 715 A.M., Detective Taylor read Zachary Pierce, and Danielle Mullener were read their Miranda Rights in which they both advised they understood. At approximately 715 A.M., Detective Taylor read the Search Warrant out loud to Zachary Pierce, and Danielle Mullener. Due to the house being separated into an apartment like setting, with different residences within, as well as separate exterior exits and entrances, only the front right room/bathroom were fully searched by Detectives and Special Agents. Detective Taylor assigned the following personnel to search the rooms and vehicles listed below: Front Right room/bathroom: Detective Capela, Corporal Santoianni, FDLE Tri-County Task Force Agents Smith, Leahy, Note. Detective Taylor instructed the Detectives searching the property to photograph any items of evidentiary value as they are found, collect them as evidence, and bring them directly to Detective Taylor at scene. Detective Capela and Corporal Santoianni conducted a search of the Front right room/bathroom of the residence and discovered the following items of evidentiary value inside of the bathroom within a Black backpack inside of a Milwaukee tool box (red in color) belonging to Danielle Mullener due to her Florida's Driver's license inside of the backpack:
